

Monthly Town Board Meeting – December 12, 2017

Chairman Curns called the meeting to order at 6:00 p.m. Notification of this meeting was given to the Press on December 1, 2017 and the final agenda was posted in the three designated places on December 8, 2017.

Approve: (a) November 14th Public Budget Hearing Minutes: Motion was made by Supervisor Shaw with a second by Supervisor Manske to approve the November 14th Public Budget Hearing Minutes. Motion carried.

(b) November 14th Special Town Meeting of the Electors Minutes: Motion was made by Supervisor Shaw with a second by Supervisor Manske to approve the November 14th Special Town Meeting of the Electors Minutes. Motion carried. Treasurer: Approve Monthly Treasurer's Report: Read by Treasurer Grove. Motion was made by Supervisor Shaw and seconded by Supervisor Manske to accept the November 30, 2017 Treasurer's Report as read & printed. Motion carried.

Motion carried. (b) Approval & Payment of Vouchers: Motion was made by Chairman Curns to approve payment of Vouchers 26863 through 26890, dated November 15, 2017 through December 12, 2017, and Direct Withdrawal of Social Security, Medicare & Federal Taxes of \$1,263.26, & December We Energies Invoice of \$526.56; for a total of \$15,379.64. Second to Chairman Curns' motion was made by Supervisor Manske. Motion carried.

Operator License Approval – Rocky's Bar & Grill – Elizabeth Wright: Supervisor Shaw made a motion to approve the issuance of an Operator License to Elizabeth Wright for Rocky's Bar & Grill. Second to the motion was made by Supervisor Manske. Motion carried.

Roads: (a) Monthly Report: Chairman Curns noted that the County Highway Department & MCC did some plowing. Town Maintenance reported that near Guth's campground, there is a lot of stone landscaping that is in the road right-of-way.

(b) Road Equipment-Report/Repairs/ Purchases Needed: Maintenance noted that front blade on snow plow truck will need to be changed.

(c) Culverts – Jennings Road: Mukwa maintenance advised that the culvert on Jennings Road, near Markman Road was plugged up with vegetation. This seems to be ongoing with this culvert.

(d) Maintenance Employee – Ross Rieck: Chairman Curns advised that Ross was a Town resident, who currently works at Curwood & helping him & he wanted offer Ross a job to help when he was available. Supervisor Manske made a motion to approve hiring Ross Rieck at \$16.00 an hour for a six month probationary time, then pay will go to \$18.00 an hour. Second to Supervisor Manske's motion was made by Supervisor Shaw. Motion carried.


