Award Contracts for Road Project Bids Received for Ferry Street, East & West Court Street, School Street & Laib Road:

Bids were received from Waupaca County Highway Department; Northeast Asphalt, MCC & American Asphalt of Wisconsin. Each proposal was submitted in a separate sealed envelope labeled with the road name per the bid specifications.

Broadway Street – Approx. 1,925 L.F. – Width Varies:

A motion to award the Broadway Street contract to American Asphalt at a cost of \$81,765.60 was made by Supervisor Shaw with a second to the motion made by Supervisor Manske. Motion carried.

Hutchison Road – (From Bean City Heading West) – Approx. 1,310 L.F. - Width 18 Foot Pavement:



A motion to award the Hutchison Road contract to MCC at a cost of \$44,569.05 was made by Supervisor Shaw with a second to the motion made by Supervisor Manske. Motion carried.

Ritchie Lane Project – Awarded in 2019 & Postponed in 2020: Chairman Curns made a motion to reestablish the contract awarded to the Waupaca County Highway Department in 2019 to ditch & pave Ritchie Lane with the slight increase agreed to by email. A second to the motion was made by Supervisor Manske and the motion carried.

Firework Display Permits Approvals – (a)Hucklberry Acres Campground – July 3rd; (b)Robert Gaskins – N4126 Poppy Parkway – July 3rd with Rain Dates of July 4th or 5th; (c)Wayne Poppy – N4176 Faskell Road – July 31st: Supervisor Manske made a motion to approve Firework Display Permits for Hucklberry Acres Campground on July 3rd; Robert Gaskins at N4126 Poppy Parkway on July 3rd with rain dates of July 4th or 5th; and Wayne Poppy at N4176 Faskell Road on July 31st noting that permits are contingent upon receipt of liability insurance. Chairman Curns made a second to the motion and the motion carried.
