## TOWN OF MUKWA AMENDED ORDINANCE 1-06 ORDINANCE ESTABLISHING TOWN PLAN COMMISSION

WHEREAS, the Town of Mukwa desires to establish a plan commission so as to be able to exercise the subdivision and land division powers set forth in Wis. Stats 236.45;

WHEREAS, such plan commission may also perform other duties on behalf of the Town of Mukwa as may be delegated from time to time by the Town Boa

WHEREAS, Wis. Stats 60.62 sets forth the statutory requirements for such plan commission;

WHEREAS, the population of the Town of Mukwa exceeds 2,500;

NOW THEREFORE, the Town Board of supervisors of the Town of Mukwa does hereby ordain as follows:

- 1. The Town Plan Commission for the Town of Mukwa, Waupaca County, Wisconsin, is hereby created.
- 2. The Commission shall consist of seven (7) members, all of who shall be appointed by the Town Board chairperson after approval by the Town Board of supervisors. The presiding officer of the Plan commission shall also be selected by the Town Board chairperson after approval by the Town Board of supervisors. At least three (3) citizen members who are not Town officials shall serve on the plan commission.
- 3. Plan commission citizen members shall be appointed for three (3) year terms. However, initially, the three citizen members shall be appointed respectively for one, two and three year terms. Town officials may be appointed not to exceed their term of office with the Town.
- 4. Commission members shall be compensated by payment of a meeting fee, to be set from time to time by the Town board. As of January 1, 2009 members shall be paid \$40.00 per meeting. Such meeting shall be called by the Town clerk or chairperson of the Commission as needed to act on Town business.
- 5. Commission members shall take an oath of office prior to commencement of duties. Any vacancy of office shall be filled by the Town chairperson as approved by the Town Board.
- 6. The Commission shall be a planning agency as provided in Wis. Stat 236.45. The Town Plan Commission is hereby granted such statutory powers as allowed by State law and authorized from time to time by the Town Board.

The above and foregoing ordinance was duly adopted by the Town Board of the Town of Mukwa, Waupaca County, Wisconsin, at the Monthly Town Board Meeting held on the 15<sup>th</sup> day of December, 2008.
