RESOLUTION 75-1-17**

“PRELIMINARY RESOLUTION TO VACATE PORTIONS OF STREETS & ALLEYS”

RE: That portion of Court Street located between Broadway Street and Ferry Street
AND
That portion of Park Street located between Broadway Street and Ferry Street
AND
That portion of Park Street located east of Ferry Street
AND
That portion of Park Street located west of School Street
AND
That portion of Church Street located south of Weyauwega Road
AND
That portion of School Street located between the Canadian National Railroad and Market Street
AND
That portion of School Street located between Mechanic Street and Market Street
AND
That portion of School Street located south of Market Street
AND
All of Jackson Street
AND
The alley running north and south through the middle of Block 23, Village of Northport
(between Highway 54 and Court Street)
AND
The alley running north and south along the east boundary of Block 3, Village of Northport
(between Market Street and Jackson Street)

WHEREAS, the Town of Mukwa Board of Supervisors wishes to vacate those portions of the platted streets and alleys above, subject to the reservation of any municipal or utility easements, if any;

WHEREAS, the statutory procedure for vacating platted streets and alleys is set forth in Wisconsin Statutes Section 66.1003;

WHEREAS, the Town Board recognizes that the streets and alley identified above have not in fact been used for street/alley purposes in recent times, if ever;

WHEREAS, it would appear to be in the public interest to vacate those portions of the streets and alleys as identified above;

NOW, THEREFORE, BE IT RESOLVED that since public interest required it, the above-described streets and alleys shall be vacated and discontinued, subject to the reservation of any municipal or utility easements;


BE IT FURTHER RESOLVED that final action on this street and alley vacation shall take place immediately following a public hearing to be held at 5:30 p.m. on August 8, 2017 at the Mukwa Town Hall, E8514 Weyauwega Road, New London, Wisconsin. Any person who wishes to object to the proposed vacation of these streets and/or alleys or make any comments regarding the same may be heard at the public hearing.

Attached hereto are maps of the streets and alleys proposed to be vacated and discontinued.

The above and foregoing Resolution was adopted by the Town Board of the Town of Mukwa, Waupaca County, Wisconsin, at the Monthly Town Board Meeting held on the 13th day of June, 2017.
